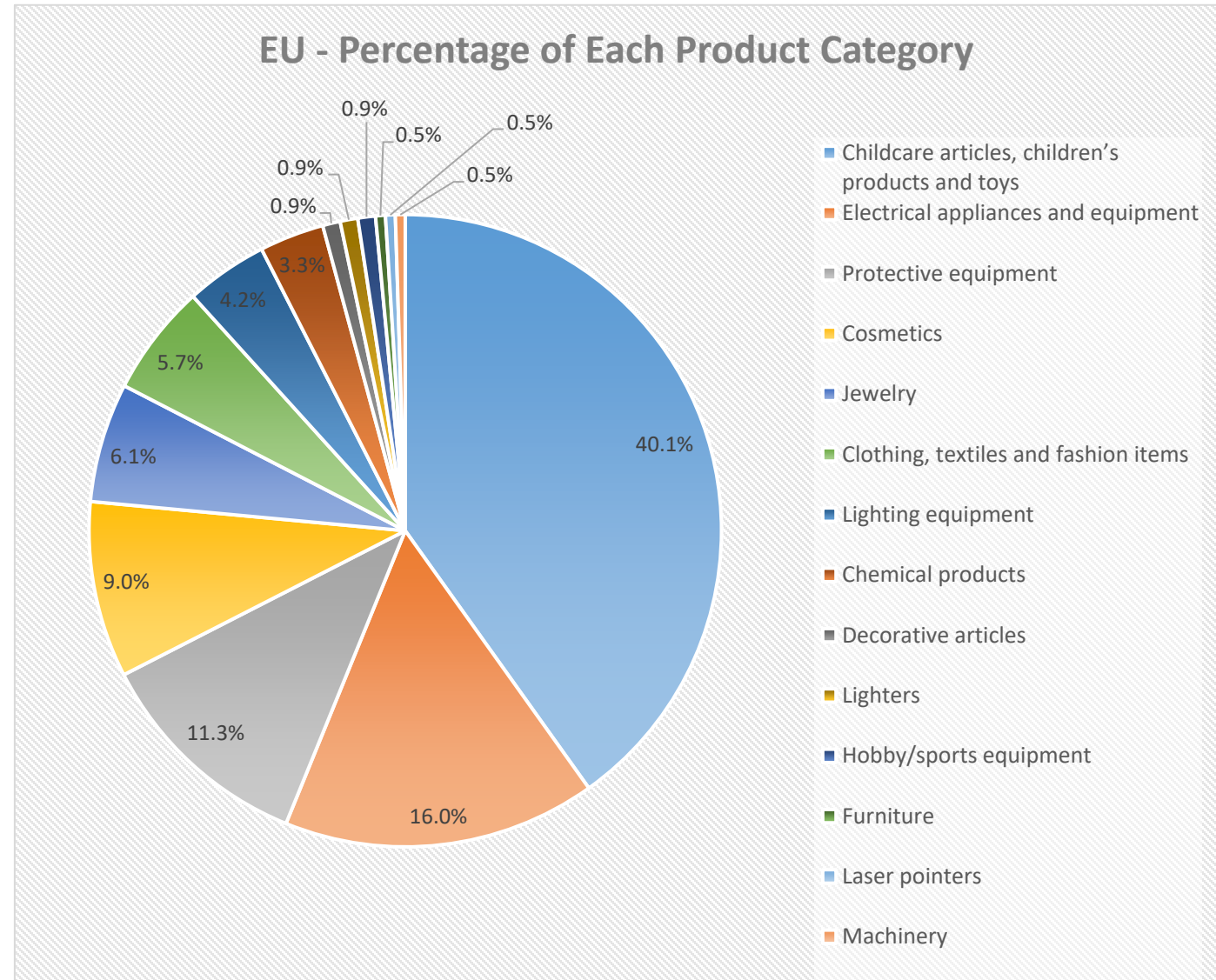

Summary

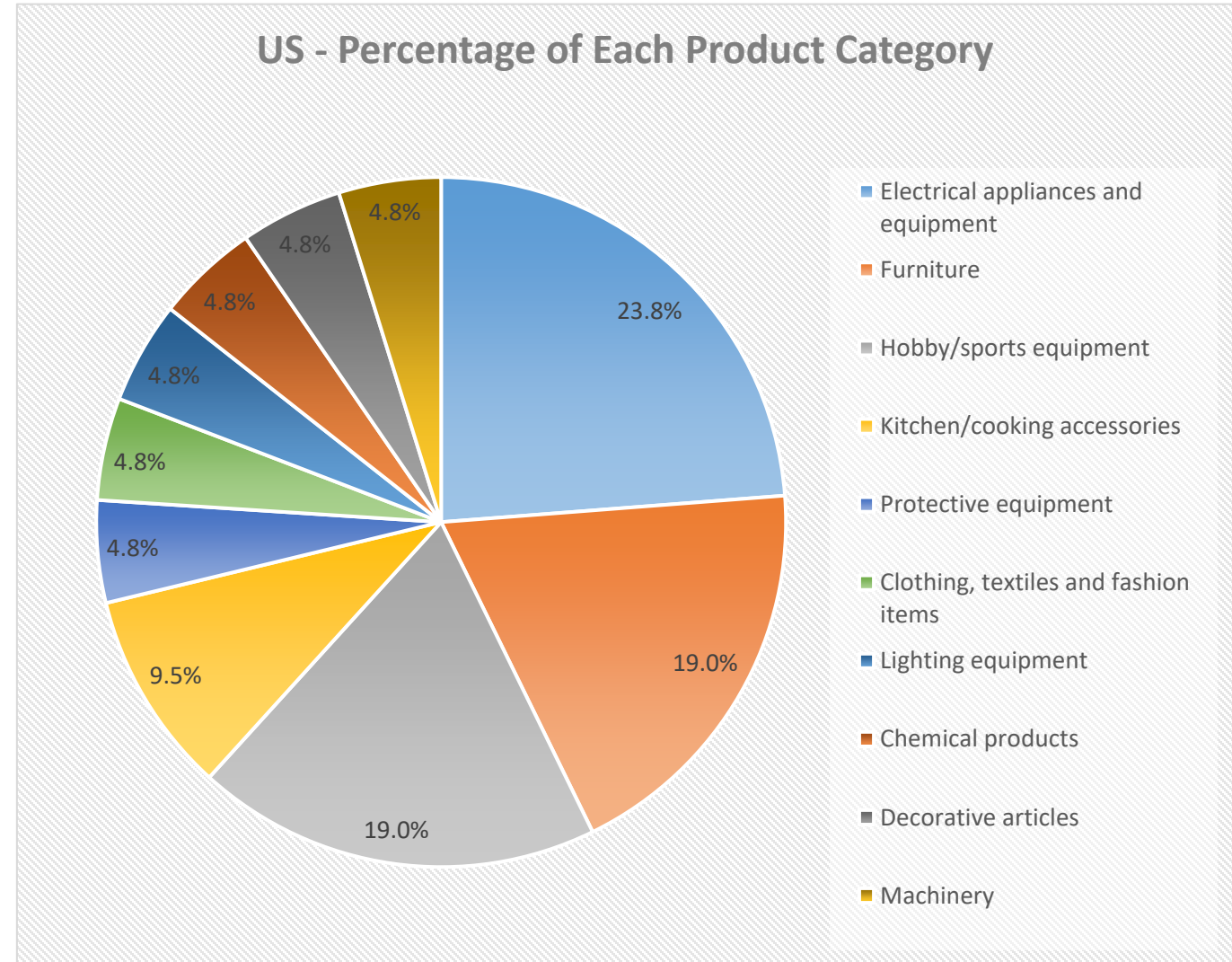

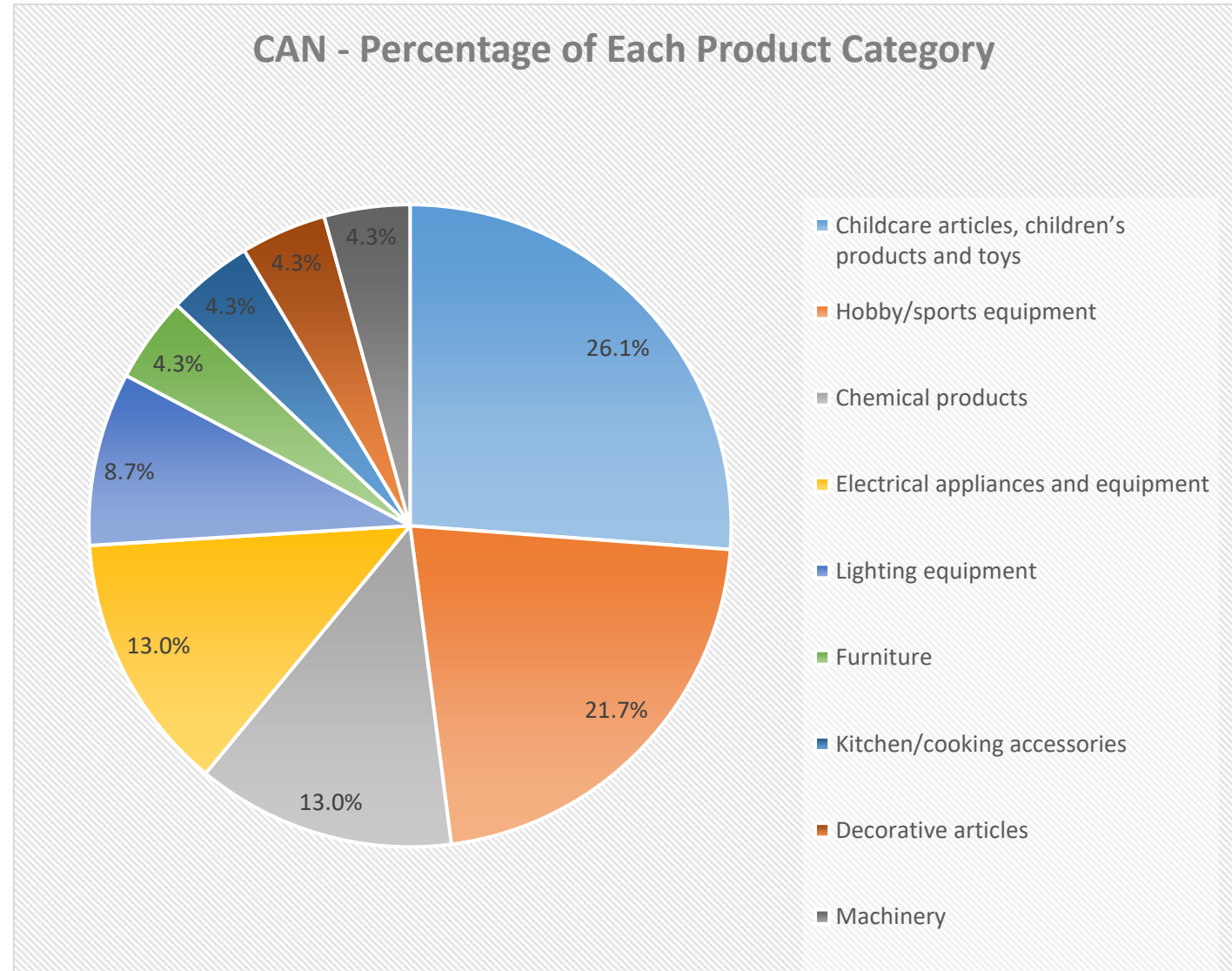

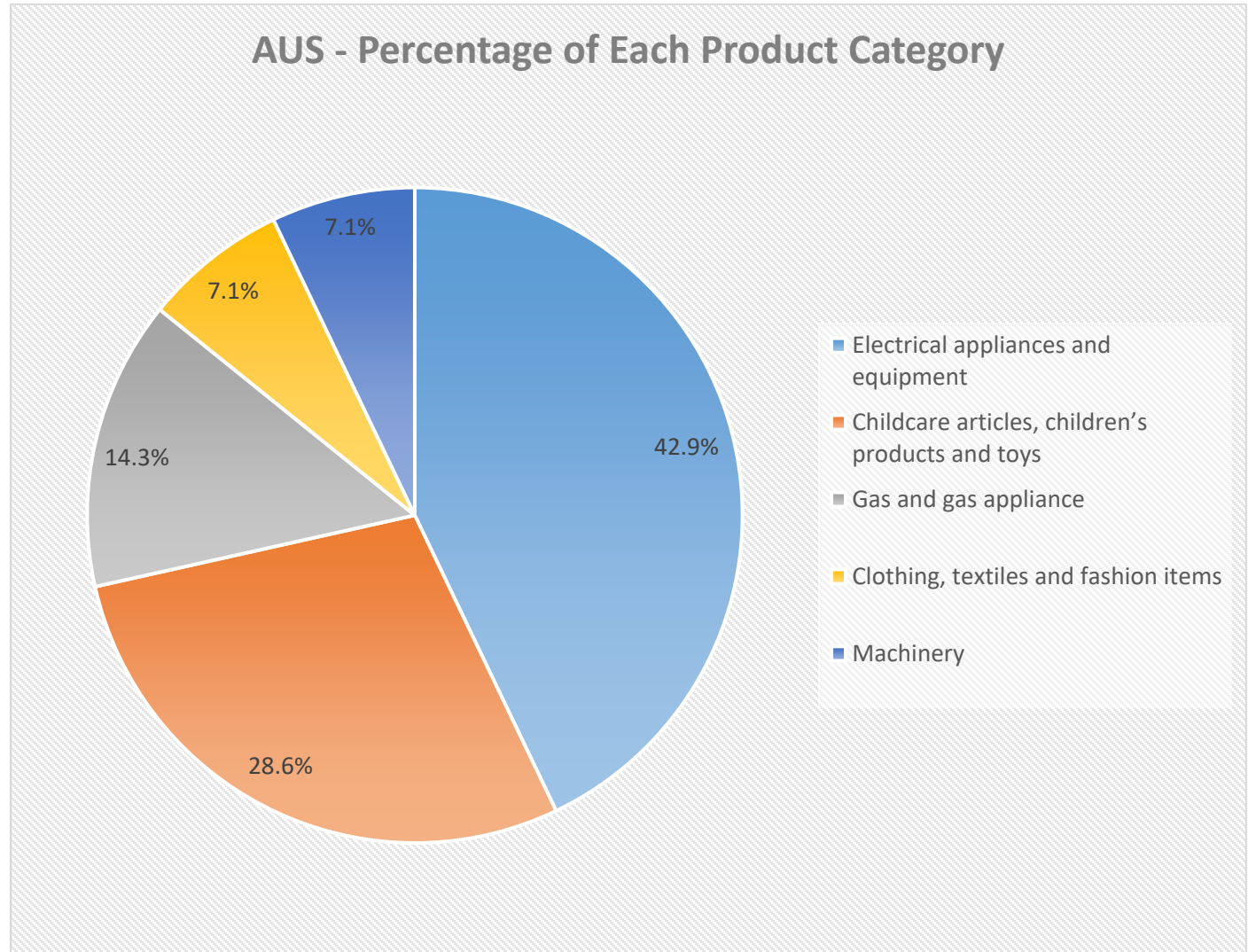
